## Company Background

The founder of the company has three decades of database experience, with its Asia database first developed in the early 1990s. EMED has more than 2.1 million carefully selected time series. Together with more than 8.5 million trend series and around 308,000 forecast series, the databases comprise approximately 11-million-time series, covering 249 countries/regions across the globe. Most of the data can be traced back to when they became available.

## Proprietary Databases

EMED organize and maintain ten major proprietary databases including Emerging Africa, Emerging Americas, Emerging Asia, Emerging CIS, Emerging EMEA, Eurostat, Forecast and G7 & Europe. The databases are updated daily whenever data is released by the primary source, through the internet, newswires, and other media channels. The data in these databases are categorized by harmonization of 23 thematic topics to facilitate fast and accurate analysis and cross referencing. The topics include:

**Emerging Africa** provides comprehensive economic and financial data for 54 major emerging markets in Africa (Angola, Burkina Faso, Burundi, Benin, Botswana, Democratic Republic of the Congo, Central African Republic, Congo Republic, Ivory Coast, Cameroon, Cape Verde, Djibouti, Algeria, Egypt, Eritrea, Ethiopia, Gabon, Ghana, Gambia, Guinea, Equatorial Guinea, Guinea-Bissau, Kenya, Comoros, Liberia, Lesotho, Libya, Morocco, Madagascar, Mali, Mauritania, Mauritius, Malawi, Mozambique, Namibia, Niger, Nigeria, Rwanda, Seychelles, Sudan, Sierra Leone, Senegal, Somalia, South Sudan, Sao Tome and Principe, Swaziland, Chad, Togo, Tunisia, Tanzania, Uganda, South Africa, Zambia, Zimbabwe). The database has over 124,500 series from primary sources, consisting of mostly annual data supplemented by quarterly and monthly data. Where necessary, documents are translated, and data is added in a standardized format for easy access on one platform. The data mostly start from when they first became available and indicators are updated as soon as they are released. The data is reported as published by the source and categorized into 13 main groups: National Accounts; Government Finance; Money & Banking; Inflation, Prices and Wages; Balance of Payments & Trade; Total Debt: Domestic & External; Business & Industry; Resources & Energy; Employment, Income & Poverty; Politics, Government & Society; Population & Health; Education; Geography & Environment.

**Emerging Americas** provides comprehensive economic and financial data for 47 major emerging markets in Latin America (Anguilla, Antigua and Barbuda, Argentina, Aruba, Bahamas, Barbados, Belize, Bermuda, Bolivia, Bonaire, Sint Eustatius and Saba, Brazil, Cayman Islands, Chile, Colombia, Costa Rica, Cuba, Curacao, Dominica, Dominican Republic, Ecuador, El Salvador, Greenland, Grenada, Guatemala, Guyana, Haiti, Honduras, Jamaica, Mexico, Montserrat, Netherlands Antilles, Nicaragua, Panama, Paraguay, Peru, Puerto Rico, Saint Kitts and Nevis, Saint Lucia, Saint Vincent and the Grenadines, Sint Maarten, Suriname, Trinidad & Tobago, Turks and Caicos Islands, United States Virgin Islands, Uruguay and Venezuela). The database has over 82,570 series from primary sources or an average of around 1,750 series for each country, mostly monthly (supplemented by daily, quarterly, semi-annual and annual data) and mostly starting from when the data first became available.

**Emerging Asia** provides comprehensive economic and financial data for 52 major emerging markets in Asia (Afghanistan, American Samoa, Australia, Bangladesh, Bhutan, Brunei, Cambodia, China (Mainland), Cocos (Keeling) Island, Cook Islands, Federated States of Micronesia, Fiji, French Polynesia, Guam, Hong Kong, India, Indonesia, Kiribati, Laos, Macau, Malaysia, Maldives, Marshall Islands, Mongolia, Myanmar, Nauru, Nepal, New Caledonia, New Zealand, Niue, North Korea, Northern Mariana Islands, Pakistan, Palau, Palestinian Territory, Papua New Guinea, Philippines, Pitcairn, Samoa, Singapore, Solomon Islands, South Korea, Sri Lanka, Syria, Taiwan, Thailand,



Timor-Leste, Tokelau, Tonga, Tuvalu, Vanuatu, and Vietnam). The database has over 303,960 series from primary sources or an average of more than 9,940 series for each country, mostly monthly (supplemented by daily, quarterly, semi-annual and annual data) and mostly starting from when the data first became available.

**Emerging CIS** provides comprehensive economic and financial data for 12 major emerging markets in the Commonwealth of Independent States (Armenia, Azerbaijan, Belarus, Georgia, Kazakhstan, Kyrgyz Republic, Moldova, Russia, Tajikistan, Turkmenistan, Ukraine, and Uzbekistan).

The database has over 64,870 series from primary sources or an average of 5,400 series for each country, mostly monthly (supplemented by daily, quarterly, semi-annual and annual data) and mostly starting from when the data first became available.

**Emerging EMEA** provides comprehensive economic and financial data for 106 major emerging markets in Europe, Middle East and Africa (Aland Islands, Albania, Algeria, Andorra, Angola, Antarctica Bahrain, Benin, Bosnia and Herzegovina, Botswana, Bulgaria, Burkina Faso, Burundi, Cameroon, Cape Verde, Central African Republic, Chad, Comoros, Croatia, Cyprus, Czech Republic, Democratic Republic of the Congo, Djibouti, Egypt, Equatorial Guinea, Eritrea, Estonia, Ethiopia, Faeroe Islands, French Guiana, Gabon, Gambia, Ghana, Gibraltar, Guadeloupe, Guernsey, Guinea, Guinea-Bissau, Hungary, Iceland, Iran, Iraq, Isle of Man, Israel, Ivory Coast, Jersey, Jordan, Kenya, Kosovo Kuwait, Latvia, Lebanon, Lesotho, Liberia, Libya, Liechtenstein, Lithuania, Madagascar, Malawi, Mali, Malta, Martinique, Mauritania, Mauritius, Mayotte, Monaco, Montenegro, Morocco, Mozambique, Namibia, Niger, Nigeria, Oman, Poland, Qatar, Republic of Macedonia, Republic of the Congo, Reunion, Romania, Rwanda, Saint Helena, Sao Tome and Principe, Saudi Arabia, Senegal, Serbia, Serbia and Montenegro, Seychelles, Sierra Leone, Slovak Republic, Slovenia, Somalia, South Africa, South Sudan, Sudan, Swaziland, Tanzania, Togo, Tunisia, Turkey, Uganda, United Arab Emirates, Wallis and Futuna, Western Sahara, Yemen, Zambia and Zimbabwe). The database has over 229,680 series from primary sources or an average of more than 2,160 series for each country, mostly monthly (supplemented by daily, quarterly, semi-annual and annual data) and mostly starting from when the data first became available.

**EuroStat** provides comprehensive and comparable data for Europe as a whole under various definitions (e.g., Euro Area, EU15, EU25, EU27) as well as for 38 individual countries (Austria, Belgium, Bulgaria, Croatia, Cyprus, Czech Republic, Denmark, Estonia, Finland, France, Germany, Greece, Hungary, Iceland, Ireland, Italy, Kosovo, Latvia, Liechtenstein, Lithuania, Luxembourg, Malta, Montenegro, Netherlands, Norway, Poland, Portugal, Romania, Serbia, Slovakia, Slovenia,



Spain, Sweden, Switzerland, Republic of Macedonia, Turkey, United Kingdom and United States). The database has over 359,530 series, mostly monthly series (supplemented by daily, quarterly, semi-annual and annual data).

**Forecast** provides comprehensive and comparable economic forecasts for 195 countries and regions based on the 22 categories of topics (excluding Daily Statistics), using the TRAMO-SEATS model. The database has over 308,780 forecasted time series or an average of 2,375 series for each country, mostly monthly (supplemented by quarterly, semi-annual and annual data) and forecasted data is extended up to the future eight years.

**G7 & Europe** provides comprehensive economic and financial data for Austria, Belgium, Canada, Denmark, Euro Area, Finland, France, Germany, Greece, Ireland, Italy, Japan, Luxembourg, Netherlands, Norway, Portugal, Spain, Sweden, Switzerland, United Kingdom and United States. The database has over 153,270 series from primary sources, mostly monthly series (supplemented by daily, quarterly, semi-annual and annual data) and mostly starting from when the data first became available.

## Multilateral Organisation and International Databases

**BIS Statistics** provides over 17,650 time series from the Bank for International Settlements international financial statistics. The database covers the global tables of the locational and consolidated banking statistics and debt securities statistics including exchange-traded derivatives, global liquidity, credit, debt service ratios, property prices, exchange rates, consumer prices and central bank policy rates.

**Organization for Economic Co-Operation and Development (OECD) Economic Outlook** contains all of the historical and forecast time series data from OECD Economic Outlook Database. In dX format, the database provides complete time series from 1970 onwards. The database contains over 26,730 annual and quarterly time series corresponding to those published in the printed publication OECD Economic Outlook as well as a large number of unpublished series. The series extend through a forecast horizon one year beyond the December and June publication dates, have a semi-annual or annual frequency, are seasonally adjusted, and are expressed at annual rates. The preliminary release of a subset of the database is in May and November each year, with the full final database release in June and December each year.

**Organization for Economic Co-Operation and Development (OECD) Main Economic Indicators** is derived from the OECD Main Economic Indicators Database. Series are included at the highest frequency (monthly or quarterly) appearing in the parent printed publication and each delivery of the database includes the full run of historical data for each series, beginning as early as 1960. The MEI database contains approximately 40,620 series for employment, unemployment and vacancies, prices and wages, industrial production, retail sales, construction, deliveries, stocks and orders, money supply, interest rates, share prices and exchange rates, national accounts aggregates, exports and imports, the balance of trade, and the current account, organized into individual country files for the OECD member countries, together with separate files covering the subject matter classifications of the printed publication. In addition to covering all OECD member countries, the database also includes data for ten major OECD non-member countries (Argentina, Brazil, China, Colombia, Costa Rica, India, Indonesia, Russian Federation, Saudi Arabia and South Africa). The database is released monthly.

**Organization for Economic Co-Operation and Development (OECD) Quarterly National Accounts** contains all of the time series data from the OECD Quarterly National Accounts Database. The database contains over 41,760 time series corresponding to those published in the printed publication, OECD Quarterly National Accounts as well as historical sets of accounts for countries that have adopted new accounts and have not extended the time series back as far as they previously had done. The database provides information on the main national accounts aggregates for member countries and for groups of countries, and tables of comparative statistics, starting as early as 1955. The database is released quarterly.

**International Monetary Fund (IMF) International Financial Statistics** provides over 324,170 time series from the International Monetary Fund's International Financial Statistics database. The database contains data for 221 countries and includes all series published in the

country pages and world and area tables of the IMF International Financial Statistics publications (monthly and Yearbook) but with more extensive time coverage. IMF International Financial Statistics on dXtime.net is organized into two databases, the first containing the series at the highest available frequency (monthly, quarterly or annual) and the second containing all annual series. The database is updated monthly.

**World Bank World Development Indicators** contains over 341,920 time series measuring macroeconomic performance (GDP, consumption, investment, international trade, balance of payments, central government budgets, prices, and money supply) for the 219 countries and territories.

## Country Databases

**Australia Bureau of Statistics (ABS) Demographic Statistics includes** the full span of data for over 11,740 demographic time series covering population by age and sex and population projections.

**Australia Bureau of Statistic (ABS) Labour force Statistics** provides over 39,530 time series for labour force status, employment and unemployment.

**Australian Bureau of Statistics (ABS) National Accounts** includes approximately 5,490 time series covering various measures of gross domestic product – expenditure, income and production, national balance sheet and government accounts.

**Australia Bureau of Statistics (ABS) State Accounts** contains approximately 4,420 time series. The database covers state-wise data for gross domestic product by expenditure, gross value added and income components.

**Australian Bureau of Statistics (ABS) Time Series Statistics Plus includes** the full span of data for approximately 39,120 series covering over 50 monthly and quarterly Australian Bureau of Statistics publications. These publications include: Quarterly National Accounts, Balance of Payments and International Investment Position, International Trade in Goods and Services, Exports and Imports, Building Statistics (approvals, commencements and activity), Demographic Statistics, Overseas Arrivals and Departures, Finance Statistics (housing, personal, commercial and lease), Exchange Rates, Private New Capital Expenditure, Inventories and Sales, Company Profits, Labour Force (Preliminary), Job Vacancies, Industrial Disputes, Wage Cost Index. Average Weekly Earnings, Wage and Salary Earners, Manufacturing Production, Retail Trade, Consumer Price Index, Housing Prices, Building and Manufacturing Price Indexes, Export and Import Price Indexes, Motor Vehicle Registrations and Tourist Accommodation. The database is updated daily as data is released by the ABS.

**New Zealand Time Series** contains a full span of data for over 18,130 economic, financial, and social time series from over 40 Statistics New Zealand Hot off the Press publications, together with

full time series from the Reserve Bank of New Zealand Financial Statistics. Areas covered include National Accounts, Balance of Payments, Overseas Trade, Government Finance, Financial Markets, Prices, Demography, Labour Market, Building and Construction, Production and Distribution, and Transport and Tourism. The database is updated daily as data is released by official agencies.

**Reserve Bank of Australia (RBA) Statistics** contains over 7,310 financial and economic time series from the Reserve Bank of Australia Bulletin Statistical Tables, RBA Statistical Releases and RBA Historical Statistics. The Bulletin Statistical Tables include series for The Reserve Bank, All Banks, Other Financial Institutions, Financial Aggregates, Government Finance, Financial Markets, Prices and Output, Balance of Payments and External Finance, and Overseas Economic Statistics. The Statistical Releases part of the database provides the Bulletin series that are updated in between Bulletin releases (e.g. Financial Aggregates, RBA Index of Commodity Prices) as well some series that are not in the Bulletin (e.g. Real Exchange Rate Indices). The Historical Data part of the database includes the RBA Australian Economic Statistics 1949-50 to 1996-97 and all of the time series from the Reserve Bank of Australia publication Research Discussion Paper 7701: Preliminary Annual Database 1900-01 to 1973-74. The database is updated daily as data is released by the RBA.

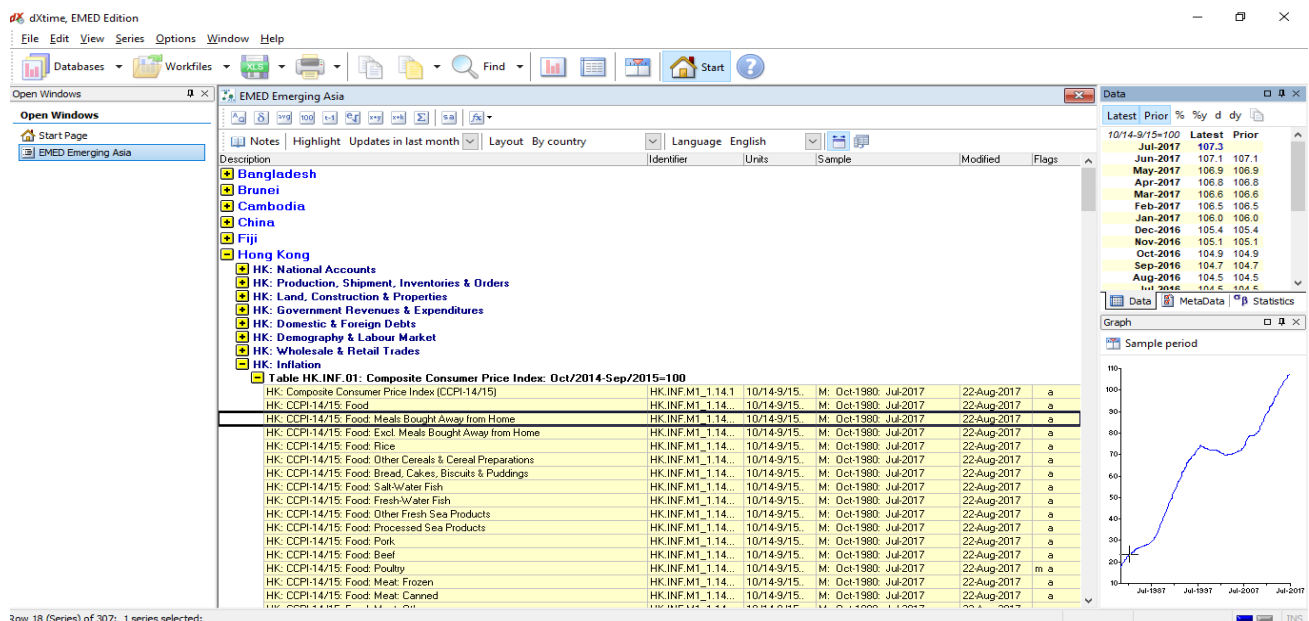

## Database Support

dXweb and dXtime are capable of handling hundreds of thousands of economic and financial times series into one single integrated environment, making data access easy, simple and fast.

The software is typically installed locally in the user's computer or network. It maintains the databases up-to-date through a small application called dXupdate that can automatically retrieve and process data updates through the internet from our server. As new data is released, dXupdate ensures that you have the latest data available, including revisions and any new series that have been included.

## Easy Navigation through a Multi-Level Database Series Directory

dXweb and dXtime are both versatile applications, powerful and simple to use. The multi-level Series Directory allows very large times series databases to be navigated easily. It supports a four-level hierarchy of database: topics, sections, tables, and times series descriptions.

Tables and descriptions are presented in a way similar to those presented in the official sources to facilitate easy and efficient data location and retrieval. The software is capable of identifying the parts of the databases that have been updated recently, and selecting multiple series at the same time for comparison and graphical presentation.

## Instant Access to the Latest Data

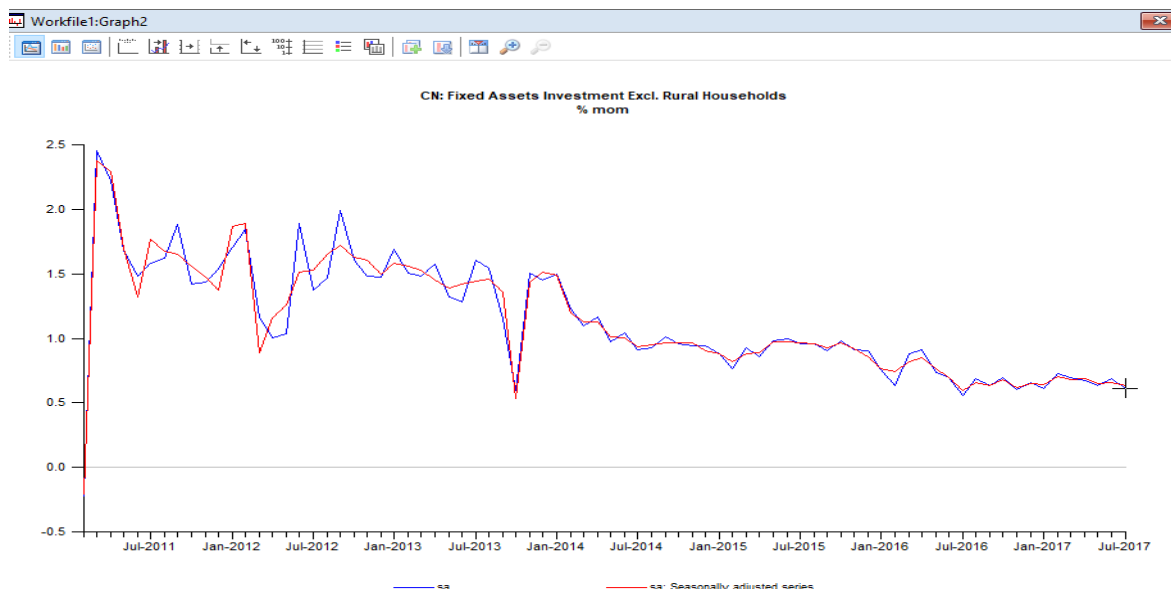
You can have instant access to the data by selecting one or more series in the Series Directory windows and dXweb and dXtime will displays a data table where you will be able to see the observations of the selected series. It also possesses the capability to illustrate simultaneously two series with different frequencies, transpose columns to rows, and if you want to focus on sub-periods of certain data you will be able to set a time frame for the display of series.

## Graphics

Graphs are useful when you want to make a quick analysis of one or more series. In dXweb and dXtime, graphs are very simple to generate; you can select one or more series in the Series Directory Windows and just by clicking a button dXtime will generate a graph instantaneously. These graphs are automatically scaled to optimize the use of available screen space and date axis scales are automatically generated to reflect the underlying series frequency. You can customize graphs in the way you wish to present. You will be able to select type graphs (Linear, bar, mixed, scatter plot, etc.), colour, axis scales, control timeframes, etc. Once you have a graph customized you can save it and recall it later on.

## Time Series Calculations

This user-friendly interface incorporates built-in tools for data manipulation that will facilitate the process of doing advanced calculations instantaneously. dXweb and dXtime incorporate a wide range of time series operations such as times series frequency transformation, calculation of percentage change (or growth rates), smooth series to facilitate forecast analysis, convert series into an index and remove seasonal factors from a series.



## Exporting and Importing Data

dXweb and dXtime are flexible in exporting data to other applications. This interface allows times series data to be written to a wide range of file formats, including spreadsheets, images, econometrics, statistical and interchange formats.

The installation package includes a dXdata add-in for Microsoft Excel which can be used to export and link series from both official databases and work files to worksheets in Excel. The worksheets can be easily updated since they are linked to the official database in dX.

Conversely, if you like to have all your work in dX format you can import time series from other data sources to Microsoft Excel spreadsheets.

## Database Notes

dXtime also provides support for textual release and explanatory notes for the databases. You can have access to these features through the Notes window in dXtime.

The Notes window makes available valuable information such as daily data releases, advance release schedules and, wherever possible, the links to the official sources of the data.

## In-house Databases

An in-house database allows a set of Workfiles to be produced as a database which can be shared among other users within your organization. In-house databases bear many features in common with official databases including controlled, read-only access to the contents of the underlying Workfiles. The database can be managed by one or a few administrators who assemble and maintain the Workfiles. These Workfiles are then made accessible to the organization's shared network at time intervals as determined by the administrators.

## Tramo Seats

TRAMO and SEATS are programs developed by Victor Gómez and Agustín Maravall for the analysis of time series. The programs, as well as documentation and various papers describing the underlying methodology, are available for download from the Bank of Spain

Note: The dXtime installation includes its own versions of the TRAMO-SEATS programs, so it is not necessary to download them in order to use the software with dXtime.

TRAMO (Time Series Regression with Arima Noise, Missing Observations and Outliers) is a program for estimating, forecasting and interpolating time series regression models. Its features include

- automatic identification and estimation of an appropriate ARIMA model;
- interpolation of missing observations which may occur in the series;
- detection and correction of several types of outlier;
- estimation of special effects such as trading day and Easter effects;
- forecasting of the original series, based on the fitted model.

SEATS (Signal Extraction in Arima Time Series) is a program for decomposing a time series into various "unobserved" components, such as the trend, seasonal and irregular. It typically receives as input the original series, along with the ARIMA model description of the series.

TRAMO and SEATS are designed to work together, with TRAMO "cleaning up" the original series, and identifying an appropriate ARIMA model, and the results being passed onto SEATS for decomposition into various components. Both programs offer many configuration options, but also offer the ability to model series in a fully automatic way. At present, dXtime uses this automatic modelling procedure when generating TRAMO-SEATS models.

When dXtime executes a TRAMO-SEATS model, it follows these steps.

1. A TRAMO input file is prepared, based on the data from the parent series.
2. The TRAMO and SEATS programs are executed in sequence (TRAMO itself prepares the input file for SEATS).
3. dXtime analyses the output of both programs.
4. New series corresponding to model outputs of interest are saved in the Series Directory.
5. Additional information, including model dimensions, parameter estimates, and diagnostic statistics are also saved in the target Workfile.

## Directory locations

Normally, it is not necessary to explicitly configure the directories used by dXtime for TRAMO-SEATS modelling. Model output directory: This directory contains the various input and output files used by TRAMO-SEATS. By default, this location is set to a Models sub-directory of your existing Work directory. If necessary, the location may be modified using the Options > Directories command.

Tip: Users interested in inspecting the full TRAMO-SEATS output will find these files in the model output directory immediately after dXtime runs a single model. If required for later analysis, they should be copied elsewhere, since these files are overwritten each time a TRAMO-SEATS model is run.

## Specifying TRAMO-SEATS outputs

The set of outputs for a particular TRAMO-SEATS model can be controlled from the Outputs tab of the TRAMO-SEATS Model dialog box. To access this dialog box

- for a new model, choose the Series > Seasonal Adjustment and Forecasting command, and then click the Additional Outputs button;
- for an existing model, select any of the current model outputs and choose the Edit > Model command.

## Some of the outputs which may be of interest include:

- Seasonally adjusted series  
The original series with the seasonal component (as estimated by SEATS) removed.
- Trend-cycle  
The original series with both seasonal and irregular components removed.
- Linearized series  
The series resulting from the removal of outliers and special regression (trading day, etc.) effects.
- Interpolated series  
The original series interpolated for any missing observations.
- Forecast original series  
The original series forecast forward using the ARIMA model from TRAMO

## Viewing model results

To view the details of the fitted model, select any model output in the Series Directory, choose the Edit > Model command, and click on the Results tab. The model results include:

- the sample period over which the model has been estimated, and also the sample period used for the full model identification procedure;
- the dimensions of the fitted ARIMA model;
- whether or not trading day and Easter effects have been included;
- the location and type of any outliers;
- a number of diagnostic statistics, which may be used to verify the suitability of the model
