
### Delivery


### Documenter – Search and Download Procedures

Once you reach <https://www.exchange-data.com/online-service/fidoc/wfi.php>, you'll be shown the following screen:

The Security ID click through on all results provides additional details relating to the security to assist with correct identification of the issue.

Clicking on the relevant document File icon will allow you to save your document to a file location of your choice. The check box located on the left-hand side of the screen gives the provision to select multiple results for grouping in a single .zip download. For large volumes of document downloads we can set up an FTP account to enable more streamlined access to the documentation.

Where a large search result is generated the user is able to save their output in .txt or .xls via the icons shown by Download \* button. This provides an overview of each security, enabling the user to assess which documents they may require at a later stage.

The 'Document Request' click through is to allow the user to make individual requests for documents which are currently unavailable. These are sent direct to our support team who will follow up using a ticketing function, designed to action and track each request.
