Company Free Float Service

The free float of a public company is the percentage of shares that are freely available to the investing public. It is a measure of how many shares are reasonably liquid.

Most indices are adjusted based on companies' free float which means companies are weighted by the total value of shares that are actually available to portfolio investors rather than the total market cap.

Providing a benchmark more closely related to what money managers can actually buy, is very useful for performance measurements.

To complement its Share Outstanding service, EDI is now offering Free Float Data from over 170 exchanges around the globe and monitoring those where data is not currently available. We review the service coverage on a regular basis and add markets to the service as and when they become available

For each market, EDI will provide the specific definition of Free-Floating Shares.

Clients can buy each data set separately and, where historical data is available, it can be purchased per year basis.

The data will contain as much detailed information as possible such as ISIN, Issuer name, to enable clear identification of each individual security.
