## Introduction to Worldwide Corporate Actions (WCA)

The Worldwide Corporate Actions service (WCA) is a cost-effective solution that helps customers manage corporate action information. Since its launch in April 2002, EDI has constantly developed this service to meet clients' ever-changing needs. In the first half of 2008, Exchange Data International concentrated on strengthening its corporate actions service by widening their security coverage to structured products and covered warrants. In addition, EDI has also added bonds that trade as equities. This means that if a security is a bond but treated and settled as an equity it will be included in our equity offering.

This service covers 114 countries. Announcements are directly sourced from exchanges and other sources globally, making a total of 400 sources on a daily basis. Our database is updated four times a day to ensure that customers receive timely information in respect of each geographic region. Asia/Pacific, Europe/Middle East and Americas are uploaded according to the different time zones.

The Worldwide Equity Corporate Actions service is programmed in the ISO 15022 message standard. And as a result, announcements are available in MT564 and 568 formats, and firms can easily populate main-frame systems and in-house security portfolios. EDI is ISO 15022 2015 compliant.

This Service is available either via a web-interface, SFTP connection and API. Subscribers of the web service also receive daily emails of new announcements for stocks in their portfolio and their selection of events.

- Key data calendar
- Event announcements
- Portfolio import facility
- Download capabilities

### US Style E2020 Feed

In US the companies will normally announce split and spin off information. For the rest of the world those events are classified as sub- division or consolidations. In order to have EDI's feed using the same naming conversion as that of the US exchanges EDI has created a new US style E2020 feed. EDI have added 3 additional events named FSPLT (Forward Split), RSPLT (Reverse Splits) and Spoff ( Spin Off ). The following event types from WCA are taken into consideration while creating this event. Bonus, Stock Dividend, Sub- division, consolidation and Demerger events.

Clients taking this feed will see the event type as FSPLT or RSPLT or Spoff instead of underlying WCA event codes.

The ratios are also adjusted so the clients will see the ratio as announced by the company.

## Event Coverage: Security Level

The current WCA feeds comprehensively covers all corporate actions events affecting global securities but can easily be customized to client's requirements in terms of geographical coverage or event types.

For each event covered by the WCA service we provide the following fields enabling an easy identification of the security affected by the event and the type of the event:

## **NEW** - Readable Corporate Action Notices (RCAN)

The Readable Corporate Action Notice (RCAN) product offers 'readable' documents that combine all the data elements that would be contained within a typical corporate actions data feed (e.g., a Microsoft Excel, CSV, or XML file), but instead, presents these elements in a human-readable form, similar to a news feed.

RCAN enables clients to read corporate actions notices the same way as they read the news. Unlike in typical corporate actions feed records, where the parts are separated out and need to be re-linked within a client-side database, the RCAN is a complete message, where all the disparate parts are pulled together.

RCAN goes even further than this, supplying various change management features, links to related notices and even additional data points that are not found in the database from which it is derived.

RCAN covers 45 corporate events, including dividends, mergers and acquisitions, new listings (IPOs), and stock splits, as well as aggregating corporate actions from over 150 exchanges globally.

The intraday RCANs are provided throughout the day as PDF or XML file formats and can be delivered by email, FTP, API, RSS, or via a search platform. Additionally, start-of-day and end-of-day summary reports are available to clients that wish to receive a consolidated list of this information.

### **Benefits of RCAN include:**

- Intraday notices are provided at four set times throughout the day — the same frequency as the corporate actions data feeds. This gives buy-side firms all the information necessary to make informed market decisions in one simple, readable format.
- Front- and middle-office workers can remain informed of data values, making operations more efficient and decreasing the chance of corporate actions going unnoticed.
- Amalgamation of disparate data sections into one simple, comprehensive document, eliminating the need for data aggregation within a client-side database.
- Inclusion of relevant information from internal and external sources, including added data values, deletions, change management features, links to related notices, and reference and events data.
